PARTICIPANT RELEASE AND WAIVER OF LIABILITY, ASSUMPTION OF RISK, COVENANT NOT TO SUE, AND INDEMNITY AGREEMENT

In consideration of being permitted to participate in the Youth Choir at the University of Redlands, I, on behalf of myself, my family, executors, estate, heirs, administrators and assigns, hereby voluntarily agree to release, waive, discharge, indemnify, hold harmless, and covenant not to sue the University of Redlands, its trustees, officers, employees, agents, volunteers, or other promoters, operators or co-sponsors of the Youth Choir, for any and all claims, damages, costs, attorney's fees, or causes of action which I have or may have in the future, or which third parties have or may have in the future, as a result of damages, injuries, including death, relating to the lifting heavy musical equipment, going up and down stairs with musical equipment, or outdoor activities in inclement weather or travel to and from the Youth Choir, arising out of or incident to any act or omission, including any negligent act or omission, by the University of Redlands, its trustees, officials, officers, employees, agents, volunteers, or other promoters, operators or co-sponsors of the Youth Choir. I knowingly and voluntarily give up valuable legal rights, including the right to sue. Further, I shall defend at my own expense, including attorney's fees, with an attorney selected by the University of Redlands, the University of Redlands in any action or proceeding, legal, administrative or otherwise, based upon acts, omissions or willful misconduct for which I am responsible.

I understand and agree that there are risks of harm associated with participating in the Youth Choir which may give rise to bodily injury, and/or property damage. These risks include, but are not limited to, Youth Choir. I understand that I will be responsible for my own transportation. I further understand and agree that there may be risks and dangers not known or reasonably foreseeable at this time. I understand and agree that included within the scope of this waiver and release is any cause of action, arising from the performance of or the failure to perform maintenance, inspection, supervision or control of the Youth Choir, or the failure to warn of existing dangerous conditions not known to or reasonably discovered by the University of Redlands, including all acts of negligence of the University of Redlands. I, the negligence of others, or by the negligence of the University of Redlands, its trustees officials, officers, employees, agents, volunteers, or other promoters, operators or co-sponsors of the Youth Choir, may cause these risks and dangers. I knowingly and voluntarily assume full responsibility for these risks arising out of or related to my participation in the Youth Choir.

I hereby grant and convey to the University all right, title, and interests in any and all photographs, images, video or audio recordings of me or my likeness or voice made by the University in connection with my volunteering in Youth Choir, including but not limited to, any royalties, proceeds, or other benefits derived from such photographs or recordings.

I further expressly agree that this agreement is intended to be as broad and inclusive as is permitted by the laws of the state or country where the Activity takes place and that if any portion of the agreement is held invalid, it is agreed that the balance shall, notwithstanding, continue in full legal force and effect.
